Procedure:

1. Durante la mezcla, agregue ácido cítrico y polyquaternium-10 al agua tibia (40-45°C). Mezclar hasta obtener una solución homogénea.
2. Agregue los ingredientes de la fase A al agua tibia (40-45°C). Mientras mezcla, agregue los ingredientes uno tras otro en el orden de la tabla anterior. Mezclar hasta que quede uniforme.
3. Agregar la fase B a la fase A. Mezclar hasta obtener una solución homogénea. Enfriar el lote a 35°C.
4. Agregue perfume y Cocamidopropyl Betaine durante la mezcla. Mezclar hasta obtener una solución homogénea.
5. Si es necesario, agregue cloruro de sodio para ajustar la viscosidad.
6. Rango de control de pH: si es necesario, agregue ácido cítrico. Mezcle bien después del ajuste.
