Procedure:

1. Dalam bekas utama gabungkan bahan-bahan dari fasa A. Tambah Xanthan Gum kepada Gliserin - gaul sehingga larutan homogen diperolehi. Masukkan air suam (50-55°C). Campurkan sehingga larutan homogen diperolehi. Homogenkan selama 2-3 minit.
2. Tambah komponen fasa B. Gaul sehingga seragam. Sejukkan batch hingga 35°C.
3. Apabila suhu kelompok ialah 35°C, tambah Cocamidopropyl Betaine semasa mencampurkan. Gaul sehingga seragam.
4. Kawal julat pH - jika perlu, tambah Asid Laktik. Gaul rata selepas pelarasan.
