Procedimiento:

1. En recipientes separados combine los ingredientes de la fase A y B.
2. Añadir la fase B a la fase A mientras se mezcla. Homogeneizar 60-90 seg. En un recipiente aparte combine los ingredientes de la fase C. Mezcle hasta que quede uniforme.
3. Añadir la fase C mientras se mezcla. Homogeneizar con 2500- 3500 RPM, 45 seg.
4. Añadir la fase D mientras se mezcla. Homogeneizar con 2500- 3000 RPM, 45 seg.
5. Agregue los ingredientes de las fases E - F mientras mezcla. Homogeneizar con 2500-3500 RPM, 90 seg.
