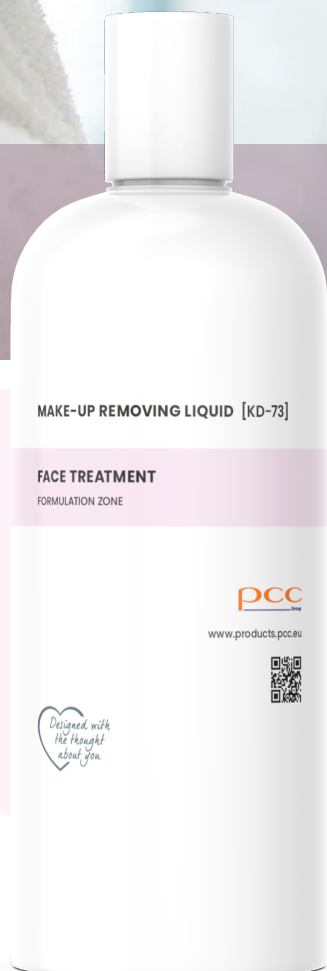

Procedure:

1. Smíchejte přísady z fáze A. Přidejte přísady z fáze A do horké vody (75-80°C). Míchejte, dokud ne získáte homogenní roztok. Vsádka se ochladí alespoň na 50 °C.
2. Přidejte přísady z fáze B. Míchejte do homogenity. Vsádka se ochladí alespoň na 30 °C.
3. V případě potřeby upravte pH kyselinou citrónovou na 5,0 - 7,0.
