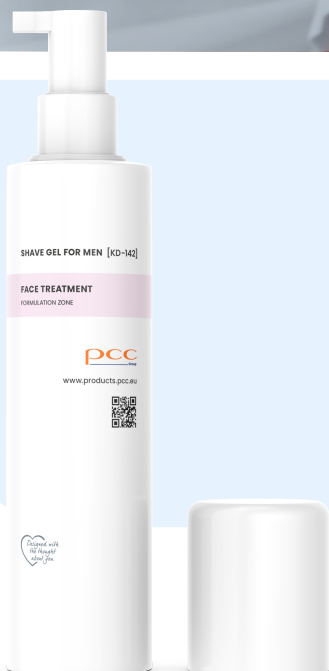

## Procédure:

- Mélanger les ingrédients de la phase A. Ajouter lentement le Carbomer à l'eau tout en mélangeant. Mélanger jusqu'à consistance uniforme. Ajoutez d'autres composants de la phase A. Homogénéiser à 2 000-3 000 tr/min, 90 à 120 secondes.
- Ajouter l'hydroxyde de sodium tout en mélangeant. Mélanger jusqu'à consistance uniforme.
- Ajouter les ingrédients de la phase C tout en mélangeant. Homogénéiser à 2 000-3 000 tr/min, 120 à 180 secondes.
