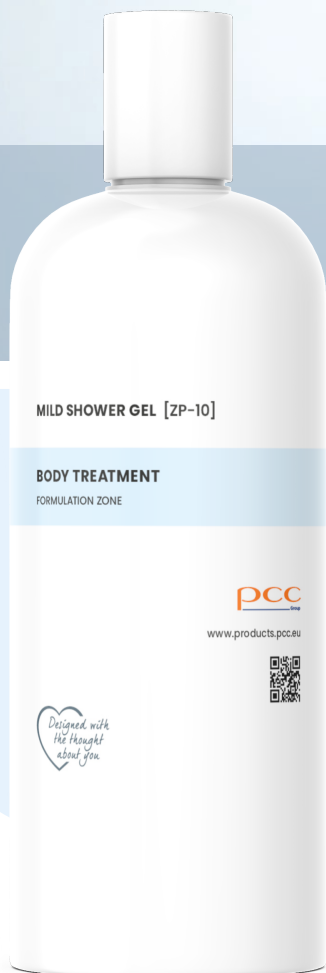

Procédure:

1. Dans un récipient principal, combiner les ingrédients de la phase A. Ajouter la gomme xanthane à la glycérine - mélanger jusqu'à l'obtention d'une solution homogène. Verser ensuite l'eau tiède (50-55°C) de la phase A dans le récipient principal et mélanger. Ajouter un conservateur. Homogénéiser 2-3 minutes.
2. Combiner les ingrédients de la phase B et mélanger jusqu'à homogénéité. Contrôlez la plage de pH - si nécessaire, ajoutez de l'acide citrique.
3. Ajouter la phase B à la phase A et bien mélanger. Refroidir le lot à 30°C et homogénéiser pendant 2-3 minutes.
