## Procedimento:

1. Em recipientes separados, combine os ingredientes das fases A e B. Homogeneize a fase A: 1500-2000 RPM 90-120 s.
2. Aqueça as fases A e B a 75-80°C.
3. Adicione a fase B a A enquanto mistura. Homogeneizar: 1500-2000 RPM 90-120 s.
4. Resfrie o lote a 30°C enquanto mistura.
5. Adicione o ingrediente da fase C enquanto mistura. Homogeneizar: 1500-2000 RPM 90-120 s.
