Procedure:

1. Skombinujte zložky z fázy A. Pomaly pridajte Acryláty/C10-30 Alkyl Acrylate Crosspolymer do vody za stáleho miešania. Miešajte, kým nebude jednotná. Pridajte ďalšie komponenty fázy A. Homogenizujte pri 2000-3000 ot./min., 90-120 s.
2. Počas miešania pridajte hydroxid sodný (20 % roztok). Miešajte, kým nebude jednotná.
3. Počas miešania pridajte zložky fázy C. Homogenizujte pri 2000-3000 ot./min., 120-180 s.
