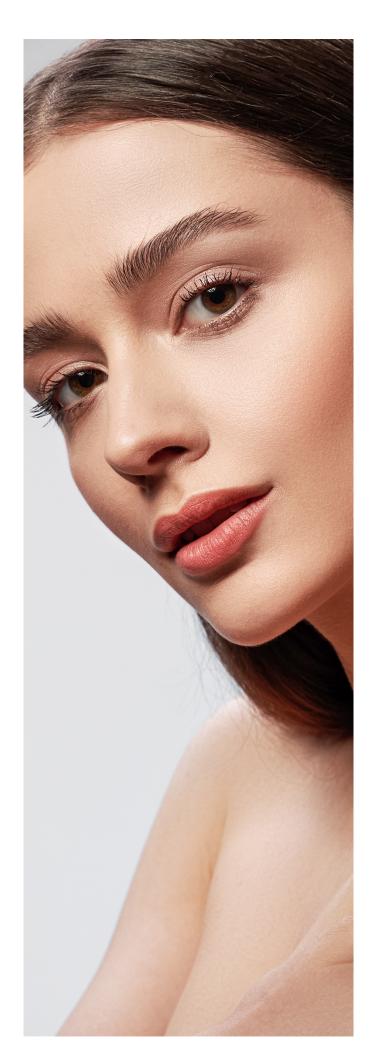

## **Procedure:**

- A 단계의 재료를 섞습니다. A 단계의 재료를 따뜻한 물 (50-55°C)에 넣습니다. 균일한 용액이 얻어질 때까지 혼합합니다.
- 2. B 단계의 재료를 섞는 동안 추가합니다. 균일해질 때까지 성느다
- 3. 혼합하는 동안 PEG-120 Methyl Glucose Dioleate와 Coco-Glucoside, Glyceryl Oleate 추가합니다. 균일 해질 때까지 섞는다. 배치를 30°C 이상으로 식힙니다.
- 4. 혼합하는 동안 Coco Betaine 천천히 첨가하십시오. 균 일해질 때까지 섞는다.
