Procedure:

1. Blanda ingredienserna från fas A i ett huvudkärl. Tillsätt Xantangummi till glycerin - blanda tills en homogen lösning erhålls. Tillsätt varmt vatten (40-50°C) och konserveringsmedel. Blanda tills homogen lösning erhålls. Homogenisera i 2-3 minuter.
2. Kombiner ingredienser från fas B. Tillsätt ingredienser från fas B till varmt vatten (40-45°C). Blanda tills homogen lösning erhålls.
3. Tillsätt fas B till fas A. Blanda tills homogen lösning erhålls. Kyl satsen ner till 30°C.
4. Justera pH till 4,8 - 5,5 genom att använda citronsyra. Blanda väl efter justering.
5. Tillsätt ingredienser från fas C. Blanda tills en homogen lösning erhålls.
