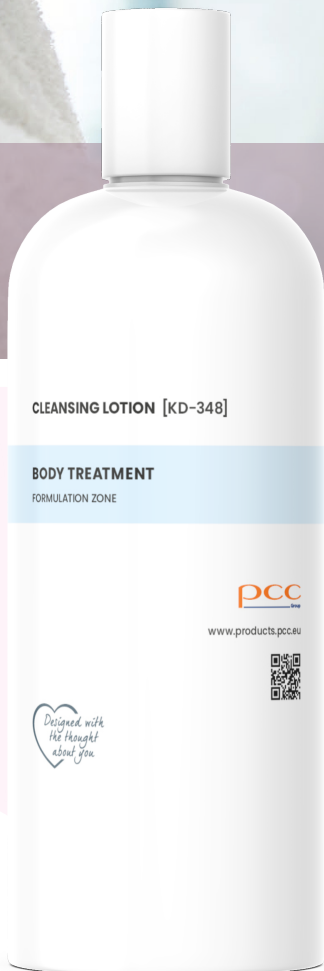

## Procedure:

1. Em um recipiente principal, combine os ingredientes da fase A. Aqueça a fase A a 75-80°C enquanto mistura.
2. Em um recipiente separado, combine os ingredientes da fase B.
3. Aquecer a fase B a 75-80°C.
4. Adicione B em A, mexa bem, mantenha A/B a 75-80°C. Homogeneizar com 2.000-3.000 RPM, 90 seg.
5. Resfrie o lote até 30°C enquanto mistura.
6. Adicione EXOsoft PC35, EXOsoft PO30 – misture até ficar homogêneo.
