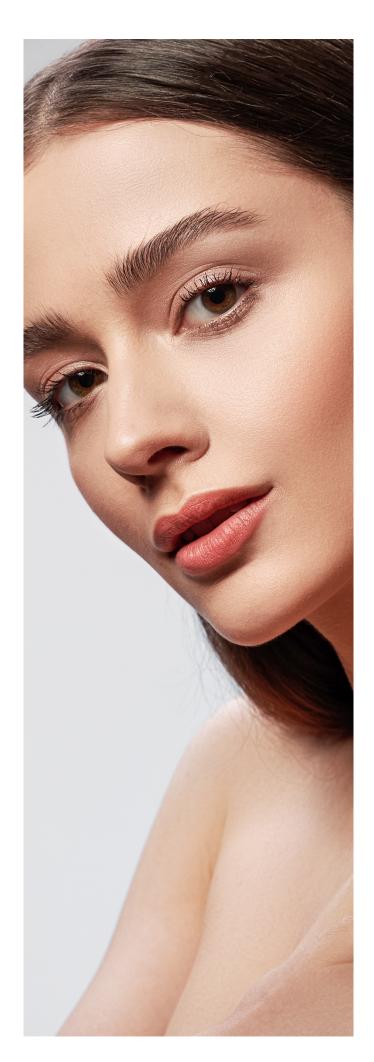

Procedure:

- 2. 암모늄 Laureth 설페이트를 추가합니다. 균일해질 때 까지 섞는다.
- 3. 단계 C의 재료를 추가합니다. 균일해질 때까지 혼합합 니다. 배치를 30℃로 식힙니다.
- 4. 혼합하면서 Cocoamidopropyl Betaine을 천천히 추가합니다. 균일해질 때까지 섞는다.
- 5. 상 E의 재료를 첨가합니다. 균일해질 때까지 혼합합니다.
- 6. 혼합하는 동안 염화나트륨을 첨가합니다(소량 첨가 및 용해).
