Procedura:

1. In un recipiente separato unire gli ingredienti della fase A, A1.
2. Preparare gli altri ingredienti – fase B e C.
3. Riscaldare le fasi A e B a 75-80°C.
4. Aggiungere lentamente la fase A1 alla fase A mescolando. Mantenere la temperatura (fase A/A1) a 75-80°C.
5. Aggiungere molto lentamente ROKAnol S20 (aggiungere una piccola porzione durante la miscelazione. Attendere fino a che non sia uniforme) alla fase A/A1 durante la miscelazione. Mantenere la temperatura di 75-80°C fino alla dissoluzione.
6. Aggiungere la fase C mescolando.
7. Raffreddare il lotto fino a 70°C.
