Procedure:

1. Vierta el agua desionizada (25-30 °C) en el recipiente principal y agregue el polímero cruzado Acrylates/C10-30 Alkyl Acrylate. Comience a mezclar cuando el polímero esté completamente mojado. Mezclar hasta obtener la solución homogénea. Homogeneizar durante 1-2 minutos.
2. Combine los ingredientes de la fase B en un recipiente separado. Calentar hasta 40-45°C con agitación suave. Mezclar hasta obtener una solución homogénea.
3. Añadir lentamente la fase B a la fase A mientras se mezcla. Mezclar hasta que quede uniforme.
4. Agregue conservante, Cocamidopropyl Betaine y perfume mientras mezcla. Mezclar hasta que quede uniforme.
