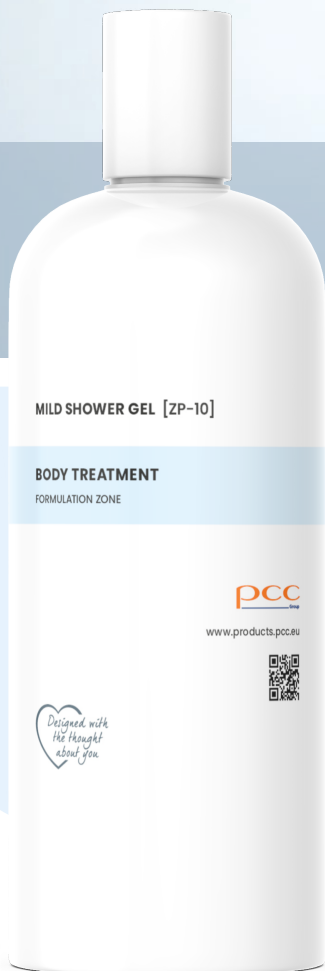

Procedure:

1. Dalam bekas utama gabungkan bahan-bahan dari fasa A. Tambah Xanthan Gum kepada gliserin – gaul sehingga larutan homogen diperolehi. Kemudian, tuangkan air suam (50-55°C) dari fasa A ke bekas utama dan gaul. Tambah bahan pengawet. Homogenkan selama 2-3 minit.
2. Satukan bahan dari fasa B dan gaul sehingga sekata. Kawal julat pH – jika perlu, tambahkan Asid Sitrik.
3. Masukkan fasa B ke fasa A dan gaul rata. Sejukkan batch hingga 30°C dan homogenkan selama 2-3 minit.
