

## Procedure:

- 1. 별도의 용기에 상 A와 B의 성분을 혼합합니다.
- 2. 단계 A와 B를 75-80°C로 가열합니다.
- 3. 혼합하는 동안 A상을 B상에 추가하고 A/B를 75-80℃ 로 유지합니다. 2000-3000 RPM, 120초로 균질화합니 다.
- 4. 혼합하는 동안 배치를 50°C로 식힙니다. 혼합하는 동 안 상 C 성분을 추가합니다. 2500-3500 RPM, 90초로 균질화합니다.
- 5. 배치를 25°C로 식힙니다. 혼합하는 동안 상 D 성분을 추가합니다. 2500-3500 RPM, 30초로 균질화합니다.
