## Procedure:

1. Em um recipiente separado, combine os ingredientes da fase A. Adicione lentamente Acrylates/C10-30 Alkyl Acrylate Crosspolymer à água enquanto mistura. Misture até ficar uniforme. Adicione outros componentes da fase A.
2. Homogeneizar com 2000-3000 RPM, 90-120 seg.
3. Adicione os ingredientes da fase C enquanto mistura. Homogeneizar com 2000-3000 RPM, 90-120 seg.
