## Procedure:

2. Tillsätt PEG-120 Methyl Glucose Dioleate under blandning. Blanda tills det är enhetligt. Kyl satsen till minst 30°C.
3. Tillsätt Cocamidopropyl Betaine och Parfum under blandningen. Blanda tills det är enhetligt.
4. Tillsätt natriumklorid under blandningen (Tillsätt små portioner och lös upp).
5. Justera vid behov pH med mjölksyra till 4,8 - 5,3.
