Procedure:

1. Combineer in een apart vat de ingrediënten van fase A, B en C. Verwarm fase A en B tot 75-80°C.
2. Voeg A toe aan B, roer goed met de hand, houd A/B op 75-80°C. Homogeniseren met 2000-3000 RPM, 120 sec.
3. Koel de batch al roerend af tot 50°C. Voeg al roerend de ingrediënten van fase C en D toe. Homogeniseren met 2500-3500 RPM, 120 sec.
4. Koel de batch af tot 25°C. Voeg tijdens het mengen fase E toe. Homogeniseren met 2500-3500 RPM, 120 sec.
