Procedure:

1. Satukan bahan-bahan dari fasa A. Masukkan perlahan-lahan Acrylates/C10-30 Alkyl Acrylate Crosspolymer ke dalam air semasa mencampurkan. Gaul sehingga seragam. Tambah komponen fasa A yang lain. Homogenkan dengan 2000-3000 RPM, 90-120 saat.
2. Tambah Natrium Hidroksida (larutan 20%) semasa mencampurkan. Gaul sehingga seragam.
3. Masukkan bahan fasa C semasa mengadun. Homogenkan dengan 2000-3000 RPM, 120-180 saat.
