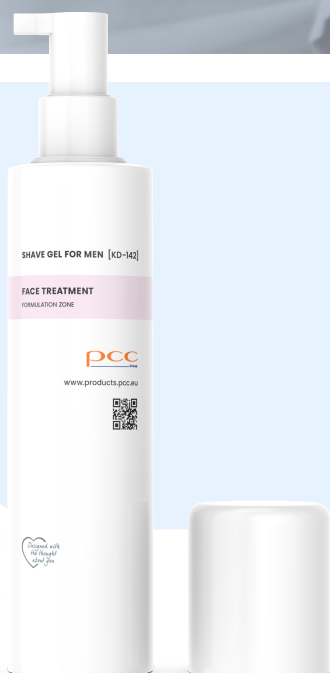

Procedure:

1. Blanda ingredienserna från fas A. Tillsätt långsamt Carbomer till vattnet under blandning. Blanda tills det är enhetligt. Lägg till andra fas A-komponenter. Homogenisera med 2000-3000 RPM, 90-120 sek.
2. Tillsätt natriumhydroxid under blandning. Blanda tills det är enhetligt.
3. Tillsätt fas C ingredienser under omrörning. Homogenisera med 2000-3000 RPM, 120-180 sek.
