## Procedure:

1. Kombinera ingredienser från fas A och B i separata kärl. Värm upp till 75-80°C
2. Tillsätt fas A till fas B under blandning. Homogenisera 60-90 sek. Blanda ingredienserna från fas C i ett separat kärl. Blanda tills det är enhetligt.
3. Kyl ner satsen till 60°C under blandning. Tillsätt fas C och D ingredienser under blandning. Homogenisera med 2500-3500 RPM, 90 sek.
4. Kyl ner satsen till 40-50°C under blandning. Tillsätt fas D, E och F ingredienser under blandning. Homogenisera med 2500-3500 RPM, 90 sek. Kyl ner satsen till 30°C under blandning.
5. Tillsätt fas F och G under blandning. Homogenisera med 2500-3500 RPM, 90 sek
