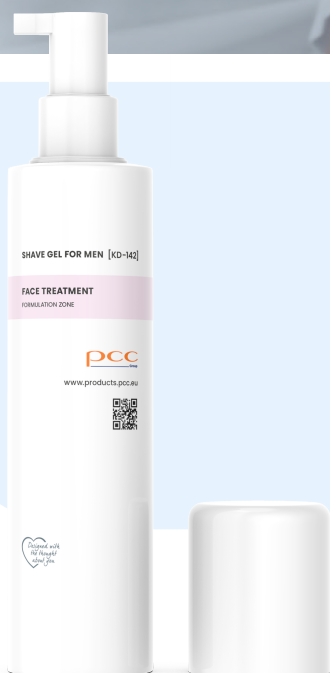

- Masukkan bahan fasa C semasa mengadun. Homogenkan dengan 2000-3000 RPM, 120-180 saat.
