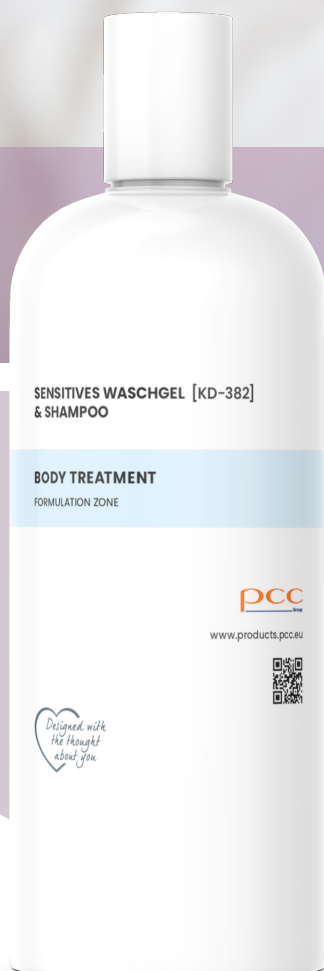

3. Ajouter lentement le chlorure de sodium. Mélanger jusqu'à homogénéité. REMARQUE : Ajouter du chlorure de sodium en petites portions. Contrôler la viscosité après chaque portion.
