## Procedure:

1. Combine los ingredientes de la fase A. Agregue los ingredientes de la fase A al agua tibia (55-60°C). Mezclar hasta obtener una solución homogénea.
2. Añadir PEG-120 dioleato de glucosa de metilo durante la mezcla. Mezclar hasta que quede uniforme.
3. Enfriar el lote a 35°C.
4. Agregue perfume y Cocamidopropyl Betaine durante la mezcla. Mezclar hasta que quede uniforme.
5. Si es necesario, ajuste el pH con ácido cítrico a 5,0 - 5,5.
