## Procédure:

1. Ajouter les ingrédients de la phase A à l'eau tiède (40-50°C). Mélanger jusqu'à homogénéité.
2. Ensuite, laissez refroidir le mélange à température ambiante avant d'ajouter un conservateur et ajoutez le reste des ingrédients.
3. Contrôlez la plage de pH - si nécessaire, ajoutez de l'acide citrique. Bien mélanger après ajustement.
