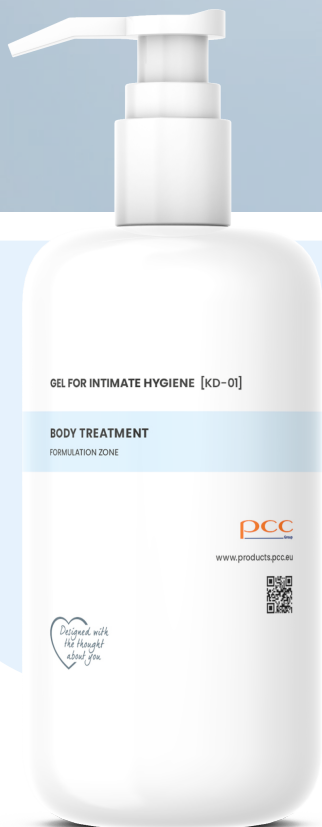

## Procedure:

3. Počas miešania pridajte parfum. Miešajte, kým nebude jednotná.
4. Počas miešania pomaly pridajte Coco Betaine . Miešajte, kým nebude jednotná.
5. Ak je to potrebné, upravte pH kyselinou mliečnou na 4,0 – 4,5.
