Procedure:

1. Em um recipiente principal, misture os ingredientes da fase A. Misture até ficar homogêneo.
2. Adicione ROSULfan A enquanto mistura. Misture até ficar uniforme.
3. Adicione lentamente ROKamina K30 e Parfum enquanto mistura. Misture até ficar uniforme.
4. Adicione EXOpearl SF enquanto mistura. Misture até ficar uniforme.
5. Adicione lentamente o cloreto de sódio. Misture até ficar uniforme. NOTA: Adicione cloreto de sódio em pequenas porções. Controle a viscosidade após cada porção.
