Procedure:

1. V oddelených nádobách zmiešajte zložky z fázy A a B. Zahrejte na 75–80°C.
2. Pridajte fázu A do fázy B počas miešania. Homogenizovať 60–90 sekúnd. V samostatnej nádobe zmiešajte zložky z fázy C. Miešajte, kým nie je homogénna.
3. Počas miešania sa dávka ochladí na 50 °C. Počas miešania pridajte zložky fázy C. Homogenizujte pri 2500–3500 ot./min., 90 sekúnd.
4. Počas miešania sa dávka ochladí na 30 °C.
5. Počas miešania pridajte fázy D a F. Homogenizujte pri 2500–3500 ot./min., 90 sekúnd
