Procedure:

3. 혼합하는 동안 PEG-120 Methyl Glucose Dioleate를 추가합니다. 균일해질 때까지 섞는다. 배치를 30°C 이상으로 식힙니다.
4. 혼합하는 동안 Cocamidopropyl Betaine 첨가하십시오. 균일해질 때까지 섞는다.
5. 젯산을 추가하여 최종 pH를 5.0 - 6.5로 재조정합니다.
