## Procedure:

1. Masukkan bahan dari fasa A ke dalam air suam (40-50°C). Gaul sehingga seragam.
2. Kemudian, sejukkan adunan ke suhu bilik sebelum menambah pengawet dan masukkan bahan-bahan lain.
3. Kawal julat pH – jika perlu, tambahkan Asid Sitrik. Gaul rata selepas pelarasan.
4. Tambah Natrium Klorida untuk melaraskan kelikatan. CATATAN. Masukkan garam (bukan sekali gus) – selepas penambahan setiap bahagian gaul rata.
