Procédure:

3. Ajouter la phase B pendant le mélange. Mélanger jusqu'à l'obtention d'une solution homogène.
4. Ajouter les ingrédients de la phase CE tout en mélangeant jusqu'à homogénéité.
5. Ajuster le pH par l'acide lactique à 5,0-5,5
