Procedure:

1. Vierta el agua desionizada tibia (40-50°C) en el recipiente principal y agregue el polímero cruzado Acrylates/C10-30 Alkyl Acrylate. Comience a mezclar cuando el polímero esté completamente mojado. Mezclar hasta obtener la solución homogénea.
2. Combine los ingredientes de la fase B en un recipiente separado. Calentar hasta 60°C con agitación suave. Mezclar hasta obtener una solución homogénea.
3. Agregar la fase B a la fase A. Mezclar hasta obtener una solución homogénea. Enfriar el lote a 30°C.
4. Cuando la temperatura del lote sea de alrededor de 30 °C, agregue conservante, propilenglicol y fragancia. Mezclar durante 20 minutos con agitación lenta.
5. Reajuste el pH final a 5,5 - 6,5 con la adición de hidróxido de sodio (30 %) si es necesario.
