Procedure:

1. Combine os ingredientes da fase A. Adicione os ingredientes da fase A à água morna (55-60°C). Misture até obter uma solução homogênea. Resfrie o lote até pelo menos 50°C.
2. Adicione os ingredientes da fase B. Misture até ficar homogêneo.
3. Adicionar PEG-120 Metil Glucose Dioleato durante a mistura. Misture até ficar uniforme. Resfrie o lote até pelo menos 30°C.
4. Adicione Cocamidopropyl Betaine durante a mistura. Misture até ficar uniforme.
5. Se necessário, ajuste o pH com ácido láctico para 4,8 - 5,3.
