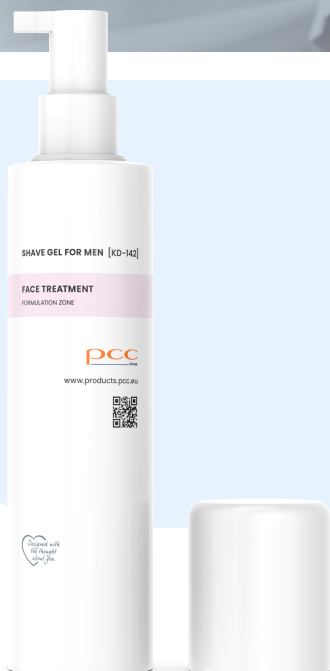

Procedure:

2. Agregue hidróxido de sodio mientras mezcla. Mezclar hasta que quede uniforme.
3. Agregue los ingredientes de la fase C mientras mezcla. Homogeneizar con 2000-3000 RPM, 120-180 seg.
