Procédure:

1. Ajouter les ingrédients de la phase A à l'eau chaude (70-75°C).
2. Tout en mélangeant, ajoutez les ingrédients les uns après les autres dans l'ordre du tableau ci-dessus. Mélanger jusqu'à homogénéité.
3. Refroidir le lot à au moins 50°C.
4. Plage de contrôle du pH. Si nécessaire, ajustez le pH avec de l'acide citrique à 5,0 - 7,0.
5. Ajouter PEG-120 dioléate de méthyl glucose pendant le mélange. Mélanger jusqu'à homogénéité. Refroidir le lot à au moins 35°C.
6. Ajouter le parfum, le conservateur et la Cocamidopropyl Betaine pendant le mélange. Mélanger jusqu'à homogénéité.
