Procedure:

1. 별도의 용기에 상 A의 성분을 혼합합니다. 아크릴레이트/C10-30 알킬 아크릴레이트 크로스폴리머를 물에 천천히 첨가하면서 혼합합니다. 균일해질 때까지 섞는다. 다른 상 A 구성 요소를 추가합니다.
2. 2000-3000 RPM, 90-120초로 균질화합니다.
3. 혼합하는 동안 상 C 성분을 추가합니다. 2000-3000 RPM, 90-120초로 균질화합니다.
