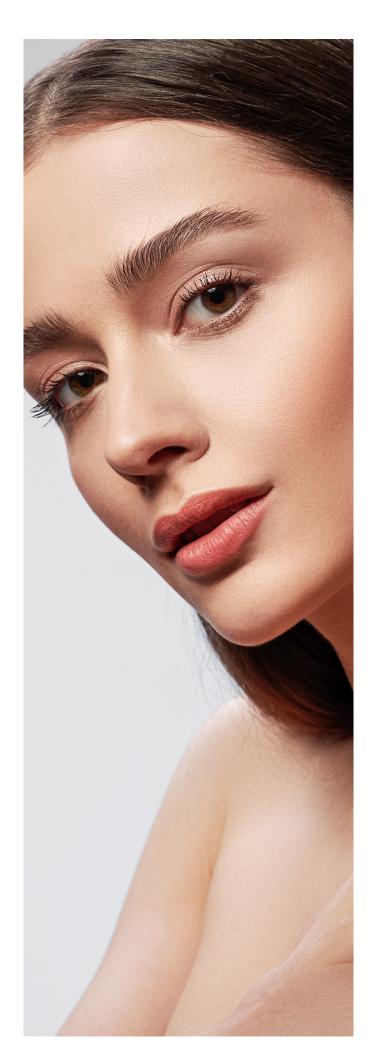

- 3. Karıştırırken partiyi 70°C'ye soğutun. Karıştırırken C bileşenlerini ekleyin. 1500-2000 RPM, 90-120 sn ile homojenize edin.
- 4. Karıştırırken partiyi 30°C'ye soğutun. Karıştırırken diğer malzemeleri ekleyin. 1500-2000 RPM, 90-120 sn ile homojenize edin.
