## Procedure:

1. Combine os ingredientes da fase A. Adicione os ingredientes da fase A à água morna (45-50°C). Misture até obter uma solução homogênea.
2. Adicione Disodium Laureth Sulfosuccinate durante a mistura. Misture até ficar uniforme.
3. Adicionar PEG-120 Metil Glucose Dioleato durante a mistura. Misture até ficar uniforme. Resfrie o lote até pelo menos 30°C.
4. Adicione Cocamidopropyl Betaine durante a mistura. Misture até ficar uniforme.
5. Reajuste o pH final para 5,0 - 6,5 com ácido láctico adicional.
