Procedure:

1. Em recipientes separados, combine os ingredientes das fases A e B.
2. Adicione a fase B à fase A enquanto mistura. Homogeneizar 60-90 seg. Em recipiente separado misture os ingredientes da fase C. Misture até ficar uniforme.
3. Adicione a fase C enquanto mistura. Homogeneizar com 2500-3500 RPM, 45 seg.
4. Adicione a fase D enquanto mistura. Homogeneizar com 2500-3000 RPM, 45 seg.
5. Adicione os ingredientes da fase E - F enquanto mistura. Homogeneizar com 2500-3500 RPM, 90 seg.
