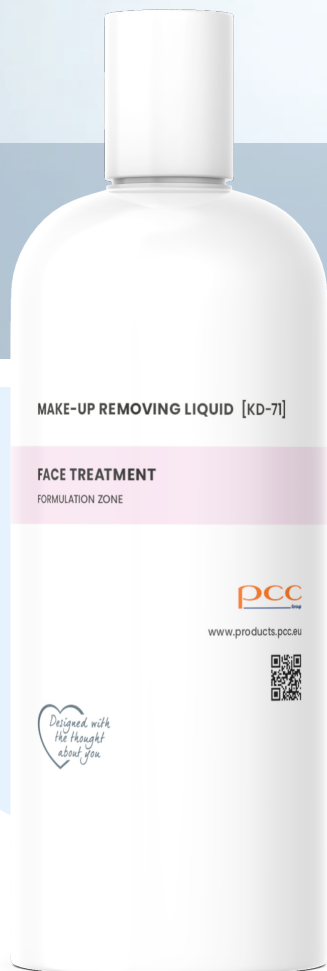

Procedure:

1. Kombinera ingredienser från fas A i ett huvudkärl och värm upp till 65-70°C.
2. Tillsätt Xantangummi till Glycerin - blanda tills det är enhetligt. Tillsätt fas B till fas A under blandning. Blanda tills det är enhetligt.
3. Kyl satsen till minst 50°C.
4. Kombinera ingredienser från fas D i ett separat kärl och blanda tills det är enhetligt.
5. Tillsätt ingredienser från fas C, D och E till fas A under blandning. Blanda tills det är enhetligt.
