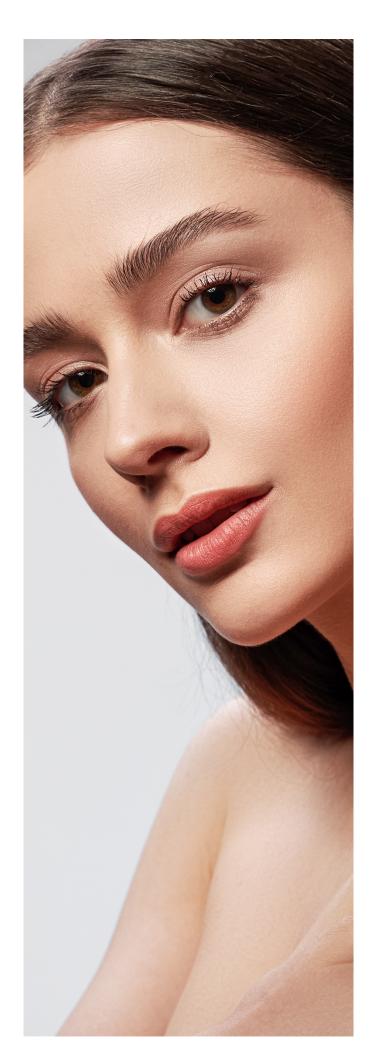

- 2. Za míchání přidejte hydroxid sodný (20% roztok). Míchejte do homogenity.
- 3. Během míchání přidejte přísady fáze C. Homogenizujte s 2000-3000 RPM, 120-180 sec.
