Procedure:

1. Combine los ingredientes de la fase A. Agregue los ingredientes de la fase A al agua tibia (45-50°C). Mezclar hasta obtener una solución homogénea.
2. Agregue Disodium Laureth Sulfosuccinate durante la mezcla. Mezclar hasta que quede uniforme.
3. Añadir PEG-120 dioleato de glucosa de metilo durante la mezcla. Mezclar hasta que quede uniforme. Enfríe el lote a por lo menos 30°C.
4. Agregue Cocamidopropyl Betaine durante la mezcla. Mezclar hasta que quede uniforme.
5. Reajuste el pH final a 5,0 - 6,5 con ácido láctico adicional.
