Procedure:

1. Kombinera ingredienser från fas A och B i separata kärl.
2. Tillsätt fas B till fas A under blandning. Homogenisera 60-90 sek. Blanda ingredienserna från fas C i ett separat kärl. Blanda tills det är enhetligt.
3. Tillsätt fas C under blandning. Homogenisera med 2500-3500 RPM, 45 sek.
4. Tillsätt fas D under blandning. Homogenisera med 2500-3000 RPM, 45 sek.
5. Tillsätt fas E - F ingredienser under blandning. Homogenisera med 2500-3500 RPM, 90 sek.
