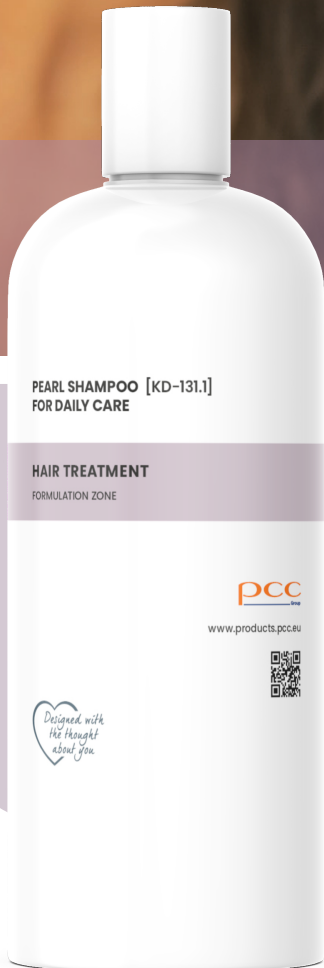

3. 혼합하면서 ROKAmina K30과 Parfum을 천천히 첨가합니다. 균일해질 때까지 섞는다.
4. 혼합하는 동안 EXOpearl SF를 추가합니다. 균일해질 때까지 섞는다.
5. 천천히 염화나트륨을 추가합니다. 균일해질 때까지 섞는다. 참고: 염화나트륨을 조금씩 첨가하십시오. 각 부분 후에 점도를 조절하십시오.
