Procedure:

1. Voeg ingrediënten uit fase A toe aan het warme water (45-50°C). Meng tot uniform.
2. Koel de batch af tot minimaal 35°C.
3. Voeg tijdens het mengen geur, PEG-7 Glyceryl Cocoate en kleurstof toe. Meng tot uniform.
4. Voeg Cocamidopropyl Betaine langzaam toe tijdens het mixen. Meng tot uniform.
5. Voeg natriumchloride toe om de viscositeit aan te passen. **OPMERKING.** Zout toevoegen (niet in één keer) – na toevoeging van elke portie goed mengen.
6. Controleer het pH-bereik - voeg indien nodig citroenzuur toe. Meng goed na aanpassing.
7. Viscositeit controleren indien nodig, natriumchloride toevoegen.
