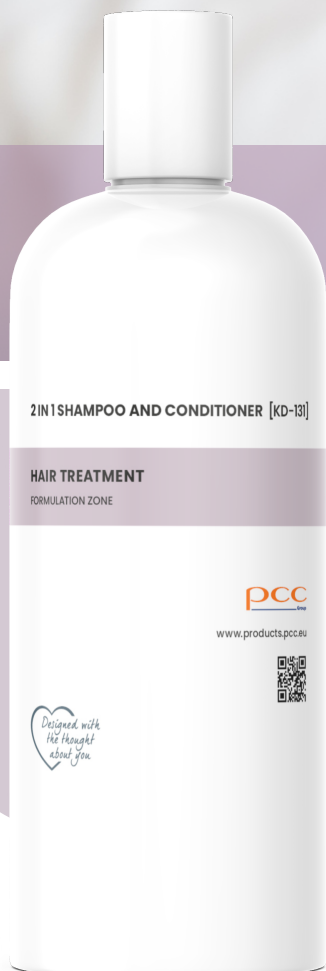

Procedure:

1. Blanda ingredienserna från fas A i ett huvudkärl – blanda tills det är enhetligt (grumlig lösning). Blanda ingredienserna från fas C i ett separat kärl – blanda tills det är enhetligt.
2. Förbered de återstående ingredienserna i separata bägare.
3. Tillsätt ingredienser från fas B – blanda tills det är enhetligt.
4. Tillsätt fas C-ingredienser under omrörning – blanda tills det är enhetligt.
5. Tillsätt fas DF-ingredienser under omrörning – blanda tills det är enhetligt.
6. Tillsätt långsamt natriumklorid under omrörning – blanda tills det är enhetligt.
