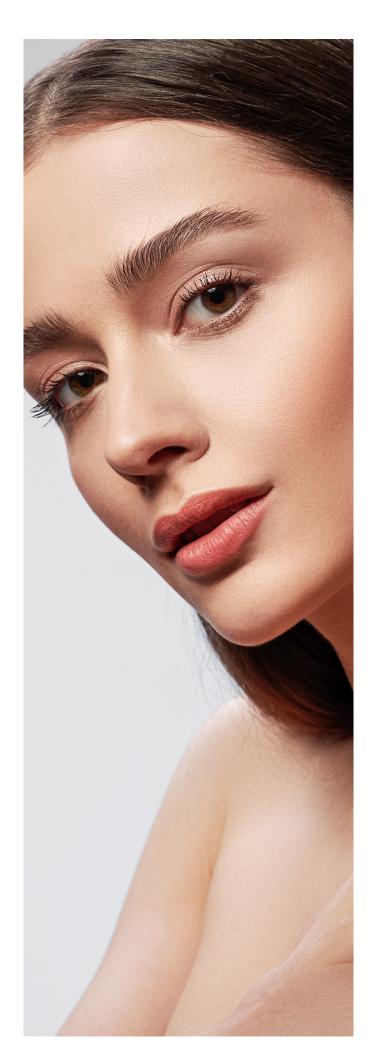

Prosedur:

- 2. Panaskan fasa A dan B kepada 75-80°C.
- 3. Masukkan fasa B ke A semasa mengadun. Homogenkan: 1500- 2000 RPM 90-120 s.
- 4. Sejukkan kumpulan hingga 30°C semasa mengadun.
- 5. Masukkan bahan fasa C semasa mengadun. Homogenkan: 1500-2000 RPM 90-120 s.
