## Prosedur:

1. Dalam bekas berasingan gabungkan bahan dari fasa A dan B. Homogenkan fasa A: 1500-2000 RPM 90-120 s.
2. Panaskan fasa A dan B kepada 75-80°C.
3. Masukkan fasa B ke A semasa mengadun. Homogenkan: 1500- 2000 RPM 90-120 s.
4. Sejukkan kumpulan hingga 30°C semasa mengadun.
5. Masukkan bahan fasa C semasa mengadun. Homogenkan: 1500-2000 RPM 90-120 s.
