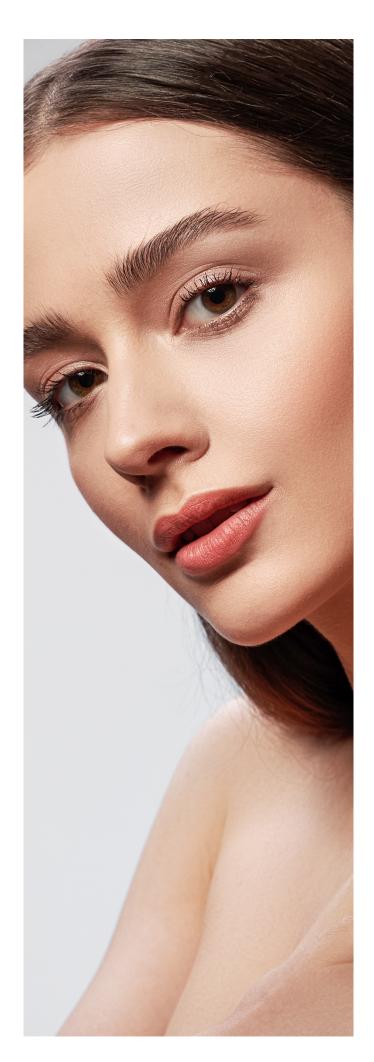

- 2. Tambah Sodium Lauroyl Sarcosinate. Gaul sehingga seragam. Sejukkan kumpulan ke sekurang-kurangnya 30°C.
- 3. Jika perlu, laraskan pH oleh Asid Sitrik kepada 5.0 7.0.
